

**MINUTES OF THE SECOND REGULAR MEETING OF THE  
BOARD OF SCHOOL TRUSTEES OF THE NORTH SPENCER  
COUNTY SCHOOL CORPORATION, LINCOLN CITY, INDIANA  
IN APRIL, 2018**

The first regular meeting of the Board of School Trustees of the North Spencer County School Corporation was held in the Superintendent's Office in Lincoln City, Indiana, with the following board members present: Mrs. Lori Gogel, Mr. Clint Coleman, Mr. Don Detzer, Mrs. Elaine Daubenspeck, Mr. Brian Gehlhausen, Mrs. Annie Oxley, and Mr. David Waninger. The meeting was held on April 23, 2018.

Following School Board Tours of the high school and middle schools, President Gogel called the regular meeting to order at 3:30 P.M.

President Gogel called for a consideration of the minutes of the regular meeting held on April 9, 2018. Mr. Clint Coleman made the motion, seconded by Mr. Don Detzer to approve the minutes. The motion carried unanimously.
